WELCOME MESSAGE FROM PISA



Dear Participants of the WISC 7th Global International Studies Conference in Warsaw,

I am honored to have the opportunity to welcome you at the University of Warsaw on behalf of the Polish International Studies Association (PISA/PTSM). The Polish International Studies Association was established not so long ago, in 2009. Our mission is to develop the discipline of international relations. Thanks to our activities, international relations have become an independent academic discipline within social sciences.

PISA/PTSM's mission refers directly to the tradition of the International Studies Conference active in the interwar period. As we know, its initiators assumed that the development of the study of international relations would contribute to mutual understanding of nations and the elimination of stereotypes and prejudices – which in turn would create conditions for security and global peace.

It seemed that after the end of the Cold War, these conditions would be fulfilled. However, the optimism of researchers of that period has long evaporated.

The Cold War era East-West division of the international system has been replaced by a new division of the Global North vs the Global South. Yet, the biggest challenge today appears to be Russia's aggression against Ukraine—a violation of the United Nations Charter. The most dangerous thing is that one of the superpowers has decided outright to use war as a means of implementing foreign policy. This is an extremely dangerous precedent.

Poland, as a host of the WISC 7th Global International Studies Conference, has Russia's aggression in mind. Yet for us—international relations scholars—issues of global governance and justice are equally important. It is for this reason that we undertook to organize another WISC Global International Studies Conference, believing somewhat idealistically, but thinking and acting realistically, that the epistemic community of WISC will contribute to a better understanding of the challenges of the current state of international relations in the world.


